Breathing Life Trust

Annual report of the Trustees for the year ended 31 March 2010.

The Breathing Life Trust is constituted by Trust Deed dated 13 December 2003 and is a registered charity (no.1102851). The charity was formed to aid relief of young persons suffering from respiratory illness or disease. To provide lung function equipment, to promote research and development of treatment and causes of respiratory diseases, the results of such research to be made public. The trustees for the year were:

Membership of the Charity shall be open to individuals or body association interested in furthering the work of the charity. The Executive Committee shall consist of not less than 3 members in addition to the Chairman Treasurer and Secretary. All members of the Executive Committee shall retire from office together at the end of the Annual General Meeting next after the date on which they came into office, but they may be re-elected or re-appointed.

Donations continued to be received from several corporate and individual benefactors and we have now received the target finances to acquire all the equipment for the new lung centre for children at the Makarios III Hoslital in Nicosia Cyprus. The new Centre opened on the 21st October 2009.

The Breathing Life Trust confirms the in excess of £2,659 on deposit at various banks in the UK and Cyprus with total donations of monies and equipment in excess of £200,000.

The Executive Committee actively reviews the major risks which the Charity faces on a regular basis and believes that maintaining reserves at the desired level combined with an Annual Review of the controls over the key financial systems will provide sufficient resources in the event of adverse conditions. The trustees have also examined other operational and business risks faced by the charity and confirm that they have established systems to mitigate risks.

Chairman's Comments Progress so far

Since 2004 the Breathing Life Trust has been raising awareness and campaigning for a dedicated modern lung centre for children, which will serve the needs of children in Cyprus and the whole region. Its opening on October 22nd 2009 was a triumph of co-operation between the Cyprus Government, London's Great Ormond Street Hospital, and The Breathing Life Trust.

The new centre is located within the Makarios III Hospotal Nicosia, which is the principal referral Paediatric Centre for the whole of Cyprus, principally to help new born babies and young children by offering advanced diagnostic techniques in the treatment of life threatening respiratory illnesses and rare genetic defects of the respiratory system. It also manages the treatment of thousands of children with severe respiratory illness and disease each year.

The Breathing Life Trust is also proud to have staged the inaugural "Art for Life" Prize 2009 Children's Art and Poetry Competition, in association with Marfin Laiki Bank and with the help of many benevolent organisations and individuals.

The Art for Life Prize is to become an annual international art and poetry competition to remind us of the need to take time to think of children suffering and in need. The competition encourages children to express through imagery and verse just how much they care about other children. Their expressions of hope share with us the enormity of love, compassion and friendship which exists between children. Art for Life is their voice and their means to help other children who have to face struggles in their lives.

Our sincere thanks to everyone for their generosity and support which has helped us so much to fulfil our dreams. For the many children participating in Art for Life, our hopes and dreams will continue to live on in your creativity and compassion. Thank you.
